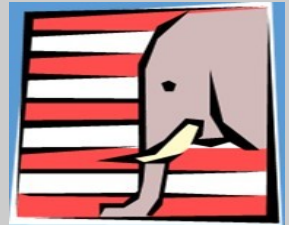

Jason has served as attorney at the Orange County District Attorney’s Office for nearly two decades. As a Deputy District Attorney, he has protected the people of Orange County by prosecuting violent criminals and getting justice for victims of murder, gang violence, robbery, carjacking and residential burglary.

He was one of the founding members of the Vehicular Homicide team, prosecuting DUI killers. He currently supervised the attorneys of the Gang/TARGET, Narcotics Enforcement Team, and Burglary Crews unit. The Gang/TARGET attorneys prosecute serious and violent felony gang crimes.

The Narcotics Enforcement Team prosecutes the most serious drug dealers who sell kilograms of illegal narcotics. The Burglary Crews attorneys prosecute home invasion residential burglars and organized retail theft.

For over a decade Jason has volunteered his time in elementary school classrooms as part of the Gang Reduction and Intervention Program (GRIP) to teach children about the dangers of gangs, drugs, and bullying. They emphasize that hard work and education is the path for students to achieve their dreams.
